



Memorandum of Understanding between
Khunying Long Athakravisunthorn Learning
Resources Center, Prince of Songkla University
and
Fudan University Library, Fudan University

Khunying Long Athakravisunthorn Learning Resources Center, Prince of Songkla University (PSU Library), Thailand, and Fudan University Library, Fudan University (FDU Library), China, believe that mutual benefits can be derived by bridging the two libraries, achieving a closer relationship by connecting personnel. Both libraries share the strong conviction that mutual understanding among people can be promoted through the establishment of academic links. Therefore, both libraries agree to enter into this Memorandum of Understanding (MOU).

Article I: Principle of Cooperation

PSU Library and FDU Library agree to develop their academic links under the principle of mutual understanding, mutual benefits, common interests, and mutually complementary activities.

Article II: Objectives of Cooperation

- (1) to promote individual contacts among personnel of both university libraries,
- (2) to promote links in research,
- (3) to provide opportunities for staff exchanges, however, such exchange need not be equally reciprocated,
- (4) to support the exchange of academic materials,
- (5) to share experiences and expertise concerning library administration and management,
- (6) to encourage any other activities that both libraries agree to be of mutual benefit.

Article III: Areas of Cooperation

Areas of cooperation can include any academic or other programs offered by PSU Library and FDU Library.

Article IV: Implementation

It is understood and agreed that:

- (1) Each university library will continue to pay the regular in-country salary of its staff members on exchange.

(2) To encourage staff mobilization, the host university library will assist in every way it could in finding reasonable accommodation for participating staffs.

(3) The host university library is not responsible for covering the costs of medical care or hospitalization for exchange personnel; instead, exchange staff should get foreign health insurance from their home country.

Article V: Duration and Termination of the Agreement

- (1) This MOU is effective as of the date of signature by the Chief Executive Officer of each participating university and remains in effect for five (5) years.
- (2) This MOU is subject to an automatic renewal for a period of five (5) years in the event that there are no requests for termination or revision.
- (3) This MOU may be amended at any time as indicated by written mutual consent.
- (4) This MOU may be terminated by either university library by the provision of a written notice of termination not less than six (6) months prior to the desired termination date. However, both university libraries agree that all continuing obligations to staff, funding bodies, or other entities are met in full subsequent to the notice of termination.
